III. HEALTH HAZARD INFORMATION

Effects of Overexposure

Inhalation: Not expected to be a hazard due to low volatility under standard conditions. Inhalation of mist or vapor may cause irritation of respiratory tract. Possible allergic reaction. May aggravate existing lung condition.

IV. FIRST AID PROCEDURES

Emergency & First Aid Procedures

Eyes: Immediately flush eyes with large amounts of water and continue flushing for 15 minutes until irritation subsides. If irritation persists, seek medical attention.

Skin: Remove contaminated clothing. Wash contaminated area thoroughly with soap and water. If redness or irritation occurs, seek medical attention.

Inhalation: This material has a low vapor pressure and is not expected to present an inhalation exposure at ambient conditions. If mist or exposure is generated when the material is heated or handled, remove victim from exposure. If breathing has stopped or is irregular, administer artificial respiration and supply oxygen if it is available. If victim is unconscious, remove to fresh air and seek medical attention.

Ingestion: Do not induce vomiting. Seek medical attention.

Notes to Physician: Aspiration may lead to chemical pneumonitis which is characterized by pulmonary

edema and hemorrhage, and may be fatal. Signs of lung involvement include increased respiration rate, increased heart rate, and a bluish discoloration of the skin. Coughing, choking, and gagging are often noted at the time if aspiration. Gastrointestinal discomfort may develop, followed by vomiting, with risk of aspiration.
